Inspection Requirements for Food Vendors

All Food Vendors who participate in events in Lawrence, KS need to contact the City of Lawrence Clerk's office for registration information.

They also need to have a current IFC 319 Mobile Food Preparation inspection. To do this please contact Jason Love, Lieutenant – Prevention Division.

Food Safety Requirements

Here are a few things that need to be available and or in place when serving the public.

1. Handwash station: hands must be washed throughout the service hours. This station needs to include running water, soap, and paper towels. No exceptions. Cloth towels are not acceptable!
2. All perishable foods (i.e., cheese, meats, and cooked vegetables) must be kept at a temperature below 41 or above 135F at all times.
3. Gloves must be worn when handling any ready to eat food items. Barehand contact is never allowed.
4. Have extra clean utensils available. Since there won't be a dish machine or 3 compartment sinks on hand; if any utensils have been dropped or used for a raw product they must be removed from service.
5. Lastly make sure all foods are protected from pests, people and the elements. Keep them covered!
